25. DECLARATIONS OF INTEREST

Mr B Sabberton-Coe declared his interest as Trustee of the Catton Park Trust.

26. MINUTES OF THE MEETING OF 23.6.2011

It was AGREED that the minutes, which had been circulated with the agenda, be confirmed as a true record and signed by the Chairman.

The meeting was adjourned for public discussion.

27. FINANCE AND POLICY COMMITTEE

27.1. Mr B Sabberton-Coe PROPOSED the confirmation, adoption and agreement of the recommendations of the minutes of the meeting of 11.7.2011. AGREED.

27.2. Changes to banking arrangements. It was noted that the funds had been successfully transferred into the new Co-operative Bank Community Guaranteed Investment accounts.

28. PLANNING AND PROPERTY COMMITTEE

28.1. Mr C Green PROPOSED the confirmation and adoption of the minutes of the meeting of 11.7.2011. AGREED.

28.2. Matters arising from the minutes

Minute 30.1. Planning permission had yet to be applied for and it was AGREED that this should be done as soon as possible for a tarmac surface.

Minute 39. Speeding in 20 mph areas. It was AGREED to ask the Police if they were now able to fine offenders.

29. DELEGATION OF AUTHORITY

It was AGREED to delegate authority to the Finance and Policy and Planning and Property Committees to act on behalf of the Council during August.

30. THE FUTURE OF STANDARDS

The meeting was broadly in favour of a local voluntary code of conduct but it was AGREED to defer full discussion of a response to Broadland District Council until the next meeting.

31. REPORT OF THE VILLAGE HALL MANAGEMENT COMMITTEE

Mr C Green reported that the urgent tree work in the car park had been carried out with the approval of Broadland District Council. The floor would be polished and decoration carried out during August.

32. CATTON PARK UPDATE

Mr B Sabberton-Coe reported that the opening of the new building, Hayman Lodge, was being arranged.
